TERMS OF DONATION

Recognition

Marketing:

KRG Children's Charitable Foundation name will appear on any form of communication, whether by newsletter, email, mail etc. sent to your funders for a period of 1 year.

The recipient of any donation from the KRG Children's Charitable Foundation must use the funds awarded for the specific purpose for what they were originally intended. Any funds not used as per specified on the application we received must be returned to KRG Children's Charitable Foundation. All successful applicants will be required to sign a Letter of Agreement prior to receiving funding.
